Tournament Director -

- -The U11 Rep tournament will be canceled for this year. The U15 ran a very successful tournament at both rinks. More fundraising was done at the Athens rink.
- -The U13 tournament was a go and everything went fairly smoothly.
- -U18 Tournament is full as of right now with 4 teams currently on hold.
- -U7 fund day is coming together nicely, we have lots of teams registered at this point. We are going to do a junior and senior tournament.
- -Upon reaching out to other teams, most are looking for multi day tournaments.
- -HEO is still stating that ourU16 tournament is a go, this will need to be changed.
- -U11 C is looking to see if any other team would be interested in running their tournament as a fundraising opportunity.
- -The online link for the tournaments has been quite successful so far, this has allowed members to follow along with the events of the day.

Referee in Chief -

- -Looking into a complaint that was received, Matt Smith is aware of the issue.
- -There have been complaints from multiple teams regarding a certain official. This has been noted and the issue is being investigated.
- -It is extremely important that managers and coaches communicate game changes with me!
- -If you have a complaint about referees it must come to me in writing and then it will be looked into.

U7 Convenor -

-U7 is running quite well, there have been some coaches and parent complaints about ice time being canceled due to tournament weekends interfering with their allotted times.

U9 Convenor -

-U9 issues have been resolved at this point. An email was sent out to coaches and managers regarding the outline for full ice games starting in the new year. They will follow the same rules as U11 with the exception that no scores will be recorded.

U11/U13 Convenor -

- -Vacant position.
- -Both teams in the U13 division have been improving from the beginning of the season.
- -The first game they played U13B1 won 3-1 against the U13B2 team, the second game resulted in a win for the U13B1 team with a score of 7-0. Then the U13B2 team claimed the Home Tournament with a score of 5-1.
- -U11 teams have been showing much improvement from the beginning of the season. They are showing closer margins with their scores in recent games.

U15/U18 Convenor -

-A few parents from the U15 team were misinformed as to how the double U15B team tournament was mandatory by the association when in fact it was put to a vote to the parents as to whether the teams actually wanted to participate in running a double rink tournament.
